MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding has been made and executed at Muzaffarnagar on this the Nineteenth day of July, year Two Thousand Seventeen.

BETWEEN

Action for Sustainable Efficacious Development and Awareness (ASEA), Rishikesh a registered Society having its registered office at 122, Vishnupuram, Rishikesh (Uttarakhand), through its Secretary Mr. Arun Kumar Sharma (hereinafter called the First Party);

AND

Internal Quality Assurance Cell (IQAC), Shri Ram College, Muzaffarnagar an Institute of higher education, accredited 'A' Grade by NAAC and affiliated with CCS University, Meerut having its campus at Parikrama Marg, Muzaffarnagar, through the Principal of the Institute (hereinafter called the Second Party).

WHEREAS, the first party is a registered Society working in the area of Environmental Consciousness, Educational Development and other Social Causes since 1995, having its office at Rishikesh (Uttarakhand) and registered under Societies Registration Act-1860. The first party is an NGO working for conducting research publications/ projects, workshops/ seminars/ conferences along with spreading awareness amongst students, youth, professionals and backward sections of the society.

AND WHEREAS, the second party has been established for running university affiliated higher education courses of C.C.S. University, Meerut (Uttar Pradesh) to provide higher education and research in various courses of Science, Commerce, Business Administration and Computer Application and to disseminate knowledge among masses of rural and urban areas.

AND WHEREAS, the first party was desirous of conducting Workshops/ Awareness Programmes at the campus and sharing learning resources with the Faculty and Students of Shri Ram College, Muzaffarnagar to cater to their needs in terms of education, research & development and providing knowledge resources. And whereas, the proposal of First Party has been accepted by the Second Party. The Second Party, as such, agrees to facilitate conducting programmes and sharing resources for which no fee shall be charged by the first party.

NOW THEREFORE, the aforementioned parties have agreed to the terms and conditions as mentioned hereinafter in order to facilitate functioning of Action for Sustainable Efficacious Development and Awareness (ASEA), Rishikesh at the campus of Shri Ram College, Muzaffarnagar;

1. That this MoU shall be in force initially for a period of three years which can be renewed further from time to time as per the mutually agreed terms and conditions.
2. That during the first six months the activities will be purely on probationary period, during which, the activities shall be closely monitored by Internal Quality Assurance Cell (IQAC), Shri Ram College, Muzaffarnagar. The Parties agree that, during the probationary period, the Principal of the College shall, upon the recommendations of the Coordinator, IQAC, has full authority and power to terminate the present MoU without assigning any reason in this regards. Conversely, the First Party shall have full freedom to close its activities, if it so wishes, after giving fifteen day notice to the Principal, Shri Ram College, Muzaffarnagar.
3. That after successful functioning for six months, it will be deemed by Parties that the probationary period has been completed successfully and thereafter the Parties shall be liable to serve at least one month's notice on the other Party before terminating the present MOU.
4. That the first party will be dedicated for organising Workshops, FDPs, Training Courses, Seminars, Conferences, Research Programmes and Projects etc. training and development of faculty and students by means of without charging fees.
5. That the Second Party shall provide necessary infrastructure without any charges with regard to Premises, Auditorium, Lecture Theatre, PA System, furniture, and other equipments including electricity supply which are deemed essential and necessary to run such activities.
6. That the First Party will provide resourcepersons and other academic resources

for running the activities, mentioned above.

7. That the First Party will also provide learning resources in terms of print, soft or online mode, if they are of the interest of the students and teachers of the College.

8. The first party and second party will, in association, conduct Awareness Programmes or Camps for Social Cause as Water Conservation, Environmental Consciousness, Cleanliness Drives, AIDS and Polio Awareness Campaigns, Blood Donation Camps, Tree Plantation or other extension or community services from time to time.

9. That no new activity shall be undertaken by the Centre without the prior approval of the Principal of the Institute.

10. That the Institute, in its own discretion, may order preponing or postponing the schedule of activity or shifting of the venue from one location to another location in the interest of the Institute.

11. That in case of any dispute or differences between the Parties, the decision of the Principal, Shri Ram College, Muzaffarnagar shall be final and binding on the both parties.
