- The concerned HOD will forward the request, with his recommendations for amount to be sanctioned, to the Principal.
- The Principal will forward it to the Secretary/ Management Committee for sanctioning the amount finally.
- The Secretary will put the request, so received, in the meeting of Management Committee or may sanction the amount himself as per the budget provisions for the particular year.
- After receiving the sanction from the Secretary, Management Committee the Principal will inform the concerned teacher in a prescribed format.
- The amount will be transferred / paid to the teacher after submitting the required document to the account section.
