And

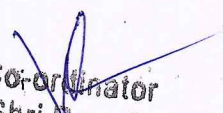
Green Land Agri Marketing India Pvt. Ltd., Muzaffarnagar (U.P.)

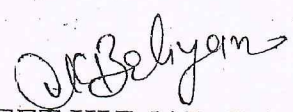

6. The Parties to this MoU may, by mutual consent, add modify, amend, or delete any words, phrases, sentences, or Articles in the MoU.

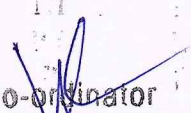
