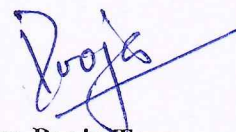
Subject: Annual Report of Internal Compliant Committee

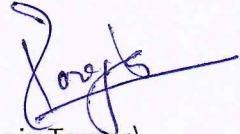
The Chairperson requested everyone to make the students aware of this policy. So that they can come forward and report such issues, if any.
